
## **Program Focus**

- Initial focus is the rurther reduction of air emissions, both methane and volatile organic compounds, from oil and gas production segment because it represents a majority of emissions from the sector
- Focus on Emission Sources:
  - Equipment Leaks
  - High-Bleed Pneumatic Controllers
  - Liquids Unloading

## **Environmental Performance Programs**

To address top-emitting sources, participating companies will implement the following Environmental Performance Programs in a manner that best suits their unique operations:

- 1. Detection and timely repair (within 60 days) of leaking equipment using optical gas imaging cameras or portable analyzers
- 2. Installation or retrofitting of high-bleed pneumatic controllers with lower-emitting or zero-bleed controllers
- 3. Implementation of a best practice to minimize emissions by monitoring manual liquids unloading events

## Reporting Requirements

- Participating companies agree to annual reporting to track progress.
- The Partnership's programs are purposefully designed to evolve and advance in response to new information that will come from its implementation.
- An annual report will be developed to document the Partnership's efforts and will be made available to the public.
- First annual reporting due in Spring of 2019.



### **Learning and Collaboration**

- Plan to host conferences for industry and to foster dialogue with other interested stakeholder groups
- On April 3<sup>rd</sup>, we held first industry-focused conference, promoted by University Lands, to discuss:
  - Proper site design to minimize tank emissions
  - Implementing a leak monitoring program
  - Regulatory developments
- Thank You to University Lands for promoting the conference – great feedback from attendees
- Planning conference for Pittsburgh, PA in July, 2018
- Annual conference planned for Sept/Oct, 2018

#### **How To Join?**

- Participation is available to natural gas and oil production companies that have onshore operations in the US.
- The voluntary program is administered by API but you do not have to be an API member to participate.
- Each participating company signs a participation agreement that commits the company to:
  - Implement the performance programs of their choosing
  - Annual reporting
  - Allow shared use of company and program logos for communications materials and website



#### What's Next?

- Continue to focus on recruitment of gas and oil production companies to join the voluntary program in 2018.
- Currently developing print ad campaign to promote the program and highlight participating companies.
